The Agricon High Point Achiever Award is designed to encourage and reward seed stock beef producers for participating and supporting Group One Agricultural Shows throughout the year.

Eligible Shows include: Bonalbo, Woodenbong, Grafton, Maclean, Nimbin, Kyogle, Casino, Lismore, Alstonville, Murwillumbah, Mullumbimby and Bangalow.

The award will be announced after Bangalow Show in 2025.

1. **The winner** of the Agricon High Achiever Award receives product to the value of \$1,750.
2. **Runner up** receives product to the value of \$875.
3. **Third place** will receive product to the value of \$440.
4. **Wild Card/Encouragement Award** will receive product to the value of \$440.

This competition is open only to exhibitors who enter beef cattle under the same Exhibitor Name throughout the competition year. No Group class points will be included.

The Agricon High Point Achiever Award will be judged based on the following points :

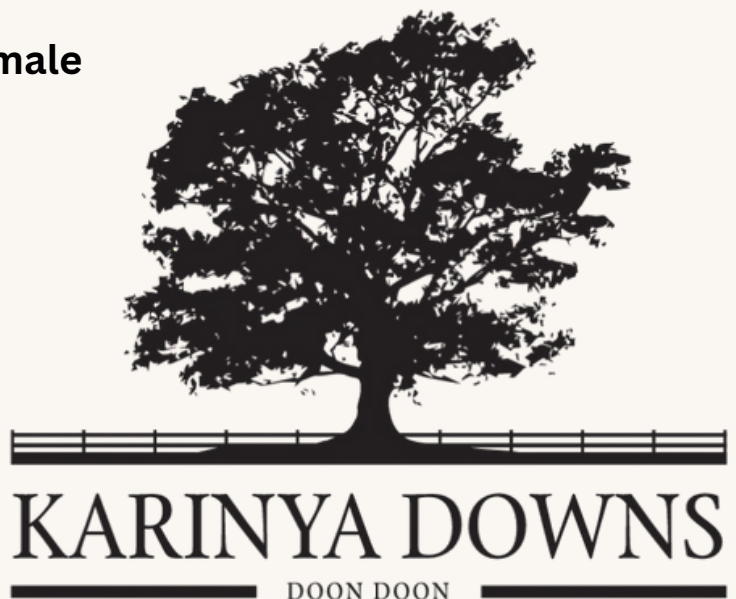

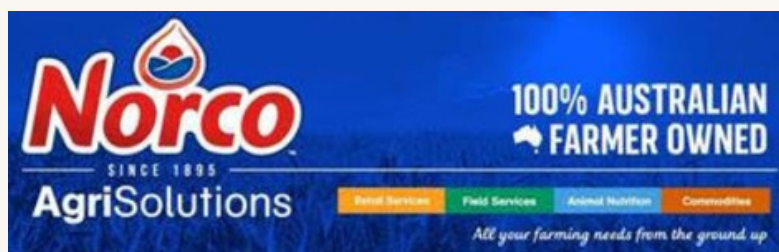
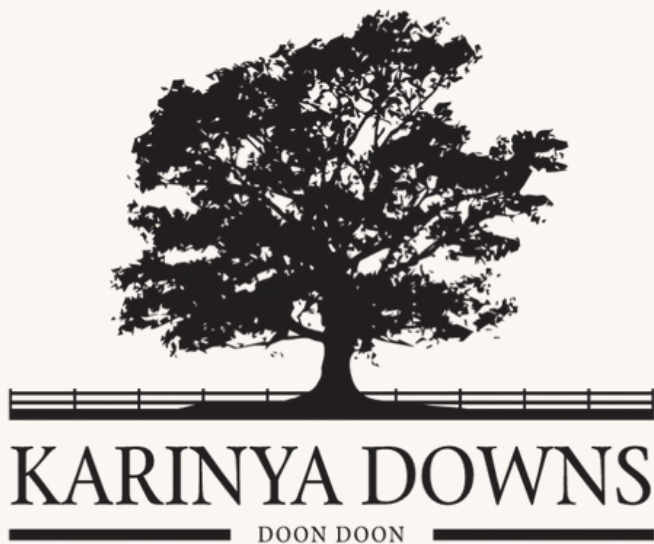

- All stud cattle must be lead, and all exhibits must be registered.
- All bull over 12 months must be rung. Under 12 months bulls and all females MUST either be rung or have nose-grips in single classes.
- The minimum age for leading bulls in the general beef classes is 12 years of age as at the date of the Show, unless otherwise stipulated.
- All stock must be eligible for registration with their respective breed societies.
- All animals being led or paraded on the Showground must have strong halters and nose lead at all times.
- All exhibitors must wear breed uniform or dust coats when parading cattle.
- It is the responsibility of each exhibitor to ensure that the leaders of their stock in judging rings and parades or elsewhere on the ground are capable of exercising control over animals in their care. Stewards reserve the right to have any animal removed from the judging ring, main area or other areas if, in their opinion, such animal is dangerous, intractable or is disadvantaging other exhibits.
- Exhibitors are advised that they must carry their own Public Liability Insurance cover and provide a copy of the Public Liability policy Certificate of Currency to the Cattle Chief Steward with the entry form.
- All first prize animals shall compete for Champion.
- If doubts arise in the mind of the judge in any class as to the classification of a competing animal, the matter will be referred to the Chief Steward for consideration.
- A heifer is a female animal which has not had a calf and is not over 3 years of age.
- The age of the cattle to be the actual age up to and including 1st of October, 2024.
- No drug, hormone or tranquiliser shall be administered to any animal exhibit except under the direction of TRAS's Veterinary Surgeon who shall advise the Senior Steward if, in their opinion, such drug, hormone or tranquilliser is likely to have any effect upon the animal which would be material to its chances of being awarded a prize and in such case the Stewards may debar the animal at any time from competing. Senior Stewards may at any time direct TRAS's Vet to take a sample of blood, saliva or urine from an exhibit for testing.
- Calves may be paraded with their mother, provided the cow is lactating and the calf is under 8 months of age. Calf can't be shown on its own in the under 12 months class, or vice versa.
- All cattle must be available for inspection to have NLIS scanned by a person nominated by TRAS at any time.
- TRAS will not hold itself responsible for any loss or mis-delivery of livestock or other exhibits at the Show or any damage thereto.
- All exhibitors must be the bona fide property of the exhibitor except where otherwise stated.
- Junior Champion will be taken from under 20 months classes.
- TRAS encourages all cattle entered and especially the prizewinning cattle to take part in the Grand Parade.
- TRAS has the right to be sole arbitrator in relation to all disputes, omission, acts, etc and such decisions shall be final and binding upon all persons affected
- To comply with Biosecurity - Fire Ants guidelines any hay/chaff bedding brought in or on site must remain on grounds.
- **Exhibitors must ensure all livestock are identified with an approved NLIS device.**
- **Exhibitors must supply to the show society with a National Vendor Declaration.**
- **All exhibitors must complete, sign and return the ASC Waiver and National Cattle Health Declaration** at the back of the Schedule to the TRAS Secretary by email or post prior to the event or hand the completed forms to the Chief Steward on the day of the event.

Fire Ant Regulations

- Under the current Emergency order you can bring anything into NSW, provided it is NOT from the known Fire ant infected zone of QLD or fire ant infected zone of NSW (Murwillumbah & Wardell) – you will need documentation (record of movement & relevant vendor declarations for the product) proving where this material/s are from (proving it is not from the known infected zone). You can however bring hay for example from the fire ant infected zone into other parts of NSW provided it had been treated. Please refer to Biosecurity (Fire Ant) Emergency Order link
- Any hay/bedding etc or any potential fire ant carrier will need to be left/ disposed of within the showground.

10. I am responsible for ensuring that I have and will wear equipment suitable for my safety in my participation of the Event and/or in using the Suppliers' facilities.
11. I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event and/or in using the Suppliers' facilities.

NATIONAL CATTLE HEALTH DECLARATION EXPLANATORY NOTES

OVERVIEW

The Cattle Health Declaration is a legal document. Please complete accurately before signing.

Cattle Health Declarations are a way for producers to provide information about the health status of the cattle they are selling. Buyers should ask vendors for a Declaration and use the information provided to determine the health risks associated with the animals on offer.

Some states/territories require testing or certification additional to that outlined in this document e.g. Johné's disease (JD) in WA and for Enzootic Bovine Leucosis (EBL) in Tasmania. Please check the entry requirements for any interstate movements at:

www.animalhealthaustralia.com.au/what-we-do/endemic-disease/livestock-movements

The original of this form is to be attached to the National Vendor Declaration (NVD) form accompanying the cattle, if applicable. A duplicate remains with the vendor; it is recommended the vendor retains a copy of this declaration for seven (7) years.

QUESTIONS 3 & 4: BOVINE VIRAL DIARRHOEA VIRUS (PESTIVIRUS) TESTING

Persistently infected animals can be detected by conducting a pestivirus antigen test. This test only needs to be conducted once in an animal's life. Cattle that test positive in most cases are persistently infected animals. Pestivirus antibody testing may be done to check the pestivirus status of the herd. Dairy cattle may be tested through bulk milk testing. Contact your veterinarian for assistance. Producers who don't know the answer to these questions should tick the 'N' box.

QUESTION 5: JOHNE'S DISEASE TESTING

Note: JD is a notifiable disease, so it is important to answer these questions.

Check test – testing of 50 adult animals in the herd (or all eligible animals in a herd if less than 50 adult animals) biased to increase the probability of detecting infection, tested by (pooled) faecal culture or (pooled) HT-J faecal PCR. An ELISA test is available but is not recommended and also not accepted for entry of cattle to WA.

Sample test – screening of the adult herd or a large representative sample of the adult herd by an approved test (pooled) faecal culture or (pooled) HT-J faecal PCR. See note above for ELISA test.

Herd Environmental Culture (HEC) Check Test (for dairy cattle) – a test of a representative sample of faecal material from the yard (see JD in *Cattle Definitions & Guidelines* for details). Details are available at www.animalhealthaustralia.com.au/jd-cattle-tools.

QUESTIONS 6 & 7: JOHNE'S DISEASE

Occurrence of JD refers to clinical disease in the herd or on the property(s). Clinical disease is an infected animal with chronic diarrhoea and weight-loss that does not respond to treatment.

The **Johné's Beef Assurance Score** (J-BAS) is a voluntary tool developed for JD risk profiling. Details are available at www.animalhealthaustralia.com.au/jd-cattle-tools. The J-BAS is an initial guide and purchasers should ask for more information about JD in the origin herd (see the JD in Cattle Biosecurity Checklist on the 'JD in cattle' webpage). The *National Farm Biosecurity Reference Manual - Grazing Livestock Production* provides a template to use for the property biosecurity plan. All plans should include the JD in Cattle Biosecurity Plan Checklist.

The **Johné's Disease Dairy Score** (JDDS) is a voluntary tool for JD risk profiling in dairy cattle. Information is available at www.dairyaustralia.com.au/bjd

Grazing of non-bovine species – Buyers of cattle from this consignment may consider the grazing of other JD-susceptible species (sheep, goats, alpacas) on the source property as important to their risk-management decisions. These buyers are entitled to seek information on how you have managed disease risks for all your livestock.

TREATMENTS & VACCINATIONS

Provide details on any cattle treatments in the last six (6) months and vaccinations within the last twelve (12) months.

Some manufacturers include more than one of the categories listed in the same vaccine, known as a combination vaccine. If you use a combination vaccine, each agent(s), as appropriate, should be detailed.

For vaccinations to be current, you must have followed the manufacturer's recommendation for vaccination. Typically, young animals or first time vaccinated animals need two (2) doses, followed by annual boosters. As variations to this general rule do occur (e.g. Siltrum is given once only), you must use the manufacturer's recommendations.

At the date the declaration is made and as a result of the vaccination(s) given, the animals are considered protected from the diseases marked as treated.
